RECOMMENDATION TO UPGRADE YOUR HEALTH FACILITY TO HOSPITAL LEVEL

Following the observation from the routine monitoring being conducted by the Jomoro District Office of the National Health Insurance Authority, we deem it necessary to recommend that per the level of infrastructure coupled with the quality of healthcare delivery, Siloam Gospel Clinic could provide more services for the people within its catchment area if it is upgraded to Christian Health Association of Ghana (CHAG) hospital level under the requirement of the Ministry of Health.

We therefore urge your organisation to expedite action on improving the level of facilities, especially, setting up an **Operating Theatre**, and recruiting **Medical Doctors** to meet the credentialing standard for upgrade to the hospital level.
